SUBJECT: Parental Notice of Availability of Voluntary Student Accident Insurance

THE SCHOOL DISTRICT DOES NOT CARRY MEDICAL INSURANCE ON STUDENTS. Expenses related to student accidents are normally covered by insurance carried by the parent or guardian, or are paid directly by the parent or guardian. This can create a hardship for families with limited or no insurance.

In an effort to avoid such a hardship, the school district offers families an opportunity to voluntarily purchase student accident insurance:

1. All benefits are excess of One Hundred (\$100) Dollars, then benefits are coordinated with other existing medical plans, or paid in full, up to preset limits, in the absence of other insurance.
2. Pays benefits directly to you or the doctor or hospital.
3. Provides coverage for accidents including sports (except Football), Gym Classes, Intramural and even Interscholastic Sports.
4. Choice of a "School-Time" Plan for \$40 or a "24-Hour" Plan for \$144.
5. Accidental Death Benefit is included with the student accident insurance.
6. Optional dental coverage available at extra cost.

Should you want an application and a brochure explaining the benefits in detail, please logon to the district's website (www.calsd.org) and select **Bollinger Voluntary Student Accident Insurance K-12** under **Site Shortcuts** on the right hand side. If you do not have access to a computer, please write your child's name in the space provided at the bottom of this letter and have your child return it to his or her homeroom teacher. The homeroom teacher will then obtain a brochure from the building administrator for your child.

Parents enrolling more than one child must use a SEPARATE APPLICATION for each child and enclose a SEPARATE CHECK OR MONEY ORDER for each child. Please send payment and application directly to **Bollinger, Inc.** Your cancelled check or money order will be your receipt.
